

# **CHAOS CORNER BULLDOGS**

## **DEPOSIT/SHIPPING**

1. Puppies are reserved and held with a deposit. Deposits are \$250 and non-refundable unless something happens with the puppy prior to new owner taking possession. Once deposit is received the puppy is marked and considered sold.
2. All shipping costs are the buyer's responsibility.

## **YOUR CHAOS CORNER PUPPY HAS THE FOLLOWING GUARANTEE**

1. To be in good physical condition for the first 48 hours after receiving the puppy. The buyer agrees to have the puppy examined by a licensed veterinarian within 2 business days of taking delivery of the puppy. If the vet finds the puppy to have a serious physical condition other than a viral/bacterial cold or infection, such as Giardia or Coccidia, which is easily treated, the breeder will replace the puppy with another puppy of comparable or better quality when available, after the puppy is returned to the breeder at the buyer's expense or put to sleep, whichever is better for the puppy. The breeder reserves the right to a second veterinarian opinion at the expense of the breeder. If the puppy is not examined within 2 business days of receiving the puppy by a licensed veterinarian, all guarantees listed are not valid unless a prior arrangement was made between the buyer and the seller.

2. To be free from any genetic health issue other than what is deemed “standard” for this breed or out of our control: cherry eyes, entropic, “loose hips”, sniffing or snorting sound when breathing, umbilical hernia, or skin allergies. We do not cover mange as it can be caused by environment, stress, and nutrition. We do not breed any dogs with these conditions such as loose hips or mange, but can not guarantee previous generations did not have these conditions. Therefore, we can not guarantee they will not show up in future litters.
3. Puppy will receive age appropriate vaccinations and several wormings. No replacements given in cases of Parvo.
4. If puppy is purchased with intention of breeding, fertility and guarantee of profits from dogs is not guaranteed. Breeding rights will be determined at the time of sale of the puppy. All puppies are considered pet only with no breeding rights, unless discussed and agreed upon by breeder at an additional cost of the puppy. Breeder will not grant breeding rights at a later time. Cost of breeding rights will be determined by sex/color/quality etc, and will start at \$1500 and up. No exceptions.
5. Breeder will not pay for surgeries such as but not limited to spay/neuter, hernia repair, orchiopexy, etc. unless a prior arrangement was agreed upon.
6. This guarantee is void if transfer of ownership occurs. The health guarantee is valid for 1 year.

**BUYER AGREES TO THE FOLLOWING:**

1. If registration is included in the sale of the puppy, the buyer agrees to use Kennel name “Chaos Corner” as the prefix in the dog’s registered name.
2. Keep the dog/puppy in human conditions, provide proper food, shelter, and clean water.
3. Maintain up to date vaccinations and wormings.

REGISTRATION:
